## Keynote Speakers



When **Meghann Foster** took office as Mayor on January 1, 2022, she became the first female mayor in Coralville's 148-year history. Foster has been a Coralville resident since 2001. She is the community engagement coordinator for the Domestic Violence Intervention Program (DVIP) and teaches strategic communication and social media marketing at the University of Iowa's School of Journalism and Mass Communication. She holds a master's in Strategic Communication from Washington State University and a bachelor's from the University of Iowa. She has been an active parent volunteer at Coralville Central Elementary, Northwest Junior

High, and West High School, and is a contributor to the Iowa City Moms Blog. Her family includes her husband and five children. In her free time, she enjoys running on Coralville's trails, watching movies, and spending time with her family.



**Shirley Welte** is vice president of Black Hills Energy Iowa Gas. She has led both electric and natural gas utilities in Iowa and Wyoming. Welte enjoys and is committed to the local community and has served as a member of the Waubensee Community College Foundation, Cheyenne LEADS and the Board of Directors of the Long's Peak Boy Scout Council. Currently, Welte serves as the Chair of the Iowa Utility Association and on the Board of Trees Forever. She is a native of Freeport, Illinois and holds a bachelor's in communications from Aurora University and a Master of Science degree in organizational management from Benedictine University.



**Andrew Busch's** unconventional path to finance, politics and the economy has taught him that the big picture is filled in by small details and requires unconventional thinking to see them. He was number six out of seven kids which taught him to scrap, shout and fight for the last piece of food at dinner. He brought this determination to his career and to his insights into the world. Before he went into finance, he painted street curbs, mowed lawns, worked construction, and ran his own painting company. All his career, he's been on the front lines of the economy and the markets. Andy traded currencies and wrote research on the markets

during the 1985 Plaza Accord; the 1998 Russian default; and to the 2008 global financial crisis. He's advised major mutual funds, hedge funds, US Treasury Secretaries and the White House. In 2017, he became the nation's first Chief Market Intelligence Officer at the CFTC. He provided economic and market briefings to the SEC, US Treasury, Federal Reserve Board, Federal Reserve of New York and the White House. He is an outside economic advisor to the White House during this time of economic uncertainty and challenges caused by the coronavirus. After a career of 35 plus years, he brings his perspective, insights and energy for fighting for the last piece of dinner to as many people and organizations as possible. Andy breaks down the economy, politics and technology to simplify the complexity and ensure that everyone can understand how they impact business and jobs. As a member of a large family and a husband/father of his own large family, Andy knows the importance of seeing through difficult, chaotic times towards the opportunities the future holds.



**Governor Kim Reynolds** is the 43rd governor of Iowa and has the distinction of being the first woman elected to the state's highest office. Her long-standing record of public service also includes serving Iowans as Lt. Governor, State Senator and Clarke County Treasurer. Reynolds' strong conservative values are reflected in her priorities for Iowa. From implementing the largest tax cut in state history, making record investments year-over-year in public schools, and enacting workforce policy initiatives that will keep Iowa's economy strong and make our state an employment destination, Reynolds is firmly committed to ensuring

Iowa is the best place to live, work, and raise a family.



**Debi Durham** is a longtime economic and community development professional who serves as executive director of the Iowa Economic Development Authority (IEDA) and Iowa Finance Authority (IFA). Prior to joining IEDA, Durham served as president of the Siouxland Chamber. Her several accolades include being recognized as one of the "Most Influential Business Leaders" in the 2019 Des Moines Business Record Book of Lists and receiving the Technology Association of Iowa's "Legislative Advocacy Leader" award in 2017. Durham was recognized by the Business Record as a "Woman of Influence" in 2016. Durham holds a B.S. in Business Administration, Marketing and Management from Missouri Southern State University.



**Beth Townsend** serves as the director of Iowa Workforce Development (IWD) and has general supervision over the various services IWD provides to Iowans. The Director prepares, administers, and controls the budget of the agency and its divisions along with Rod Roberts, Commissioner of the Division of Labor and Joseph S. Cortese, II, Commissioner of the Division of Workers' Compensation. Director Townsend has been in her current position since 2015 when she was first appointed by Governor Branstad and unanimously confirmed by the Iowa Senate on March 24, 2015. Director Townsend was reappointed by Governor Reynolds in January 2019, and again confirmed by the Iowa Senate. Director Townsend previously served as the Director of the Iowa Civil Rights Commission. Director Townsend served in the Air Force Reserve and retired as a Lieutenant Colonel after 21 years of active and reserve duty.



**Dr. Ann Lebo** was appointed as director of the Iowa Department of Education in March of 2020. Lebo previously served as executive director of the Iowa Board of Educational Examiners, where she had been since 2016. She was previously a secondary principal in Grundy Center, an adjunct faculty member in education and leadership at Waldorf University and serves as Iowa's Chief Talent Officer for the Council of Chief State School Officers. Lebo was an athletic coach and English instructor at the secondary and postsecondary levels for 17 years and worked in the private sector for five years. Lebo also served on the statewide Teacher Leadership and Compensation Task Force in 2012 and was appointed to the Governor's STEM Advisory Council in 2017. Dr. Lebo holds an Ed.D. and Ed.S. both in Educational Administration, a M.A. in English Language and Literature, a B.A. in English Education, and a B.A. in Speech Communication.



**Kathryn Kunert** is the vice president of economic connections and integration for MidAmerican Energy. She joined the government affairs department as a legislative grassroots coordinator in 1996. During her career, she has had responsibilities in the areas of government affairs, community relations, economic development and corporate communications. In her current role, Kunert oversees key accounts, business accounts, business and community development, franchises, sponsorships and donations, and other special projects. **Stuart Anderson** graduated with a bachelor's degree in Civil Engineering from Iowa State University in 1991 and has worked for the Iowa DOT since that time. Anderson is director of the Transportation Development Division which is responsible for multimodal transportation planning, programming, and project development activities.



**Staci Hupp Ballard** is a proud Iowan who has been telling the story of this great state for much of her professional life. Ballard was named chief strategic communications officer for the Iowa Economic Development Authority (IEDA) and Iowa Finance Authority (IFA) in April 2020. **Dan Clark** is the director of Iowa Prison Industries (IPI), a work training program for men and women incarcerated within Iowa's nine state prisons. Every day, more than 900 men and women in the IPI program learn to weld, learn to work as a team, learn to use the tools of lean manufacturing, and learn the skills that will help them obtain good paying jobs upon their release. IPI work training programs provide Iowa employers with a skilled and motivated workforce and improve the success rate for reentering citizens. Prior to joining IPI, Dan spent 30 years in private industry. He holds an M.B.A. from the University of Buffalo and an M.S. from the Rensselaer Polytechnic Institute in Troy, NY. Dan and his spouse Kristin reside in West Des Moines, Iowa.



**Scott Drzycimski** is director of public affairs at ITC Midwest. For years, he has worked for Midwest utilities in media relations, marketing, economic development, community relations and large customer engagement. Prior to joining ITC Midwest, Drzycimski spent nearly 18 years with Alliant Energy. The CIRCA program provides occupational training to incarcerated individuals and case management and support for one year after release from incarceration.

Chris is the CIRAS Technology Assistance Program (TAP) Director. In this role he leads CIRAS efforts in building technical skills and deploying advanced technology in Iowa manufacturers.

Working at a refugee center in Athens, Greece, Iowa native **Dustin Miller** had an epiphany. "Over a meal and a game of backgammon with a Sudanese refugee, it hit me that I'd rather use my mind to affect public policy that impacts people than to simply serve people meals," he says. "That's why I decided to go to law school instead of international development." World travels and noteworthy personal experiences have shaped Dustin's approach to life and law. From community service projects at home and abroad to working in microfinance in Kenya, traveling during upheavals in Beirut, and sailing the English Channel, Dustin gained cultural insights and an appreciation for diversity. As legislative counsel at Nyemaster Goode, Dustin primarily represents Iowa-based associations as a lobbyist at the Iowa Legislature and with the agencies of the State of Iowa. His work involves a wide range of public policy issues, such as water quality, environmental issues, economic development, taxation, public finance and utilities.
